## How to Use This Template

### Replace all prompts with your own details.

Replace each prompt and blank line with your personal information, your children's details, and the information of the nominated guardian. Ensure all sections are completed, including the declarations and signatures.

### Sign the completed document in the presence of two witnesses

Two independent witnesses (not the nominated guardian) must sign the form.

### Keep copies.

Keep the completed document in a safe place and share a copy with the nominated guardian.

### Note:

This is not a legally binding guardianship appointment (as only a will can appoint a legal guardian), but it clearly records the parent's wishes and can support legal processes if needed.) This document records the parent/legal guardian's preferences only and does not replace a legally valid guardianship appointment in a Last Will and Testament. For formal legal guardianship arrangements, professional legal advice is advised.
